DECLARATION OF EXTENDED STATE OF EMERGENCY

1. The recent Coronavirus Disease 2019 (“COVID-19”) pandemic now includes more than 15,000 positive cases of COVID-19 in Sarasota County. The COVID-19 pandemic continues to pose a significant risk to the health and safety of the population.

2. The COVID-19 pandemic’s potential for transmission throughout the population, attachment to surfaces for prolonged periods of time thereby causing property damage and increasing the potential for transmission, and increased strain on existing health care resources creates the threat of significant public and private financial loss and poses an immediate and present danger to the health and safety of the citizens of Sarasota County, necessitating the exercise of all reasonable preparatory, precautionary, and remedial measures.

3. The COVID-19 pandemic constituted a natural disaster for Sarasota County warranting the declaration of an emergency pursuant to Section 252.38(3)(a)5, Florida Statutes on March 15, 2020 and the declarations of an extended emergency pursuant to Section 252.38(3)(a)5, Florida Statutes, on March 22, 2020, March 29, 2020, April 5, 2020, April 12, 2020, April 19, 2020, April 24, 2020, May 1, 2020, May 8, 2020, May 15, 2020, May 22, 2020, May 29, 2020, June 5, 2020, June 12, 2020, June 18, 2020, June 25, 2020, July 2, 2020, July 9, 2020, July 16, 2020, July 23, 2020, July 30, 2020, August 6, 2020, August 13, 2020, August 20, 2020, August 27, 2020, September 3, 2020, September 10, 2020, September 17, 2020, September 24, 2020, October 1, 2020, October 8, 2020, October 15, 2020, October 22, 2020, October 29, 2020, November 5, 2020, November 12, 2020, November 19, 2020, November 25, 2020, and December 2, 2020.

4. It is the intent of Sarasota County that by declaration of this extended state of emergency, Sarasota County may invoke the powers granted to it pursuant to Section 252.38, Florida Statutes, and its adopted emergency management plan. It is further the intent of Sarasota County that by declaration of this extended state of emergency, Sarasota County, its citizens and municipalities may be eligible for financial assistance available through the state or federal government.

5. In accordance with the Governor’s Executive Order No. 20-51, which declared a state of emergency due to the threat of the COVID-19 pandemic and Governor’s Executive Orders Nos. 20-52, 20-68, 20-69, 20-71, 20-80, 20-82, 20-83, 20-85, 20-86, 20-87, 20-88, 20-91, 20-92, 20-93, 20-94, 20-95, 20-103, 20-104, 20-111, 20-112, 20-114, 20-120, 20-121, 20-123, 20-131, 20-137, 20-139, 20-149, 20-150, 20-159, 20-166, 20-179, 20-180, 20-192, 20-193, 20-210, 20-211, 20-213, 20-244, 20-246, 20-275, 20-276, and 20-297, which implemented further statewide measures to address the emergency, it is the intent of Sarasota County that by declaration of this extended state of emergency, Sarasota County shall make available all public resources necessary to mitigate the potential transmission of COVID-19 pursuant to the Sarasota County Comprehensive Emergency Management Plan.

6. Pursuant to the authority delegated to me by the Board of County Commissioners in the Sarasota County Comprehensive Emergency Management Plan and under Sarasota County Code Section 2-217(h)(1), I may declare the existence of an emergency procurement condition and suspend any or all of the provisions of the Procurement Code and authorize emergency procurement.

7. Pursuant to the authority delegated to me by the Board of County Commissioners in the Sarasota County Comprehensive Emergency Management Plan together with the authority granted to Sarasota County under Section 252.38(3)(a)(5), Florida Statutes, I promulgate the following Declaration, to take immediate effect:

SECTION 1. Extension of Declared State of Emergency.

Because of the foregoing conditions, it is hereby declared that due to the COVID-19 pandemic a state of emergency continues to exist in Sarasota County. It is further declared that the COVID-19 pandemic is a natural emergency, as defined in Chapter 252, resulting in substantial damage to or loss of property that has caused or threatens to cause injury or harm to the citizens of Sarasota County. By this declaration, Sarasota County hereby invokes the emergency management powers granted to it pursuant to Section 252.38, Florida Statutes, its adopted emergency management plan and the Governor's Executive Orders Nos. 20-51, 20-52, 20-68, 20-69, 20-71, 20-80, 20-82, 20-83, 20-85, 20-86, 20-87, 20-88, 20-91, 20-92, 20-93, 20-94, 20-95, 20-103, 20-104, 20-111, 20-112, 20-114, 20-120, 20-121, 20-123, 20-131, 20-137, 20-139, 20-149, 20-150, 20-159, 20-166, 20-179, 20-180, 20-192, 20-193, 20-210, 20-211, 20-213, 20-244, 20-246, 20-275, 20-276, and 20-297.

SECTION 2. Authorization to Apply for Federal and State Assistance.

Sarasota County is hereby authorized to apply for any federal or state financial assistance to assist in responding to and recovering from the COVID-19 pandemic including financial losses and illnesses as a result of the impacts sustained to Sarasota County and its residents.


SECTION 3. Declaration of an Emergency Procurement Condition.

Sarasota County hereby declares an emergency procurement condition continues to exist and suspends all the provisions of the Procurement Code and Procurement Manual and authorizes emergency procurements. The County Administrator hereby delegates his procurement authority under this Declaration to the Sarasota County Procurement Official.

SECTION 4. Effective Date, Duration and Area.

This Declaration shall take effect immediately and shall be effective throughout Sarasota County, including its municipalities. The state of emergency declared herein shall remain in force for seven days from the date hereof, unless extended pursuant to Section 252.38, Florida Statutes.
