2. Boats may be powered by paddles, oars or sails, no engines or machine assistance.
3. No foam, fiberglass, epoxies, two part paints or plastic structural components allowed.
4. Maximum of 6 people per boat and all must wear footwear and CG approved life vests.
5. **BOATS MUST BE REGISTERED IN EACH CLASS THEY RACE IN**
